# **Sports Premium Policy**

## **Sports Premium Policy**

### **Aims:**

- to ensure we promote and support the importance of a healthy lifestyle and place particular emphasis on the wellbeing of our pupils;
- to ensure that pupils will learn how sport and activity impacts positively on all aspects of their lives and on that of the school;
- to improve the physical education experience for all children in our school;
- to increase physical activity opportunities for our children;
- to enable our children to enjoy a range of school sport outside of the curriculum;
- to ensure access for all children to high quality physical education lessons to develop fitness, stamina, health and well-being;
- to ensure the development of school sport is linked to wider agendas;
- to strategically use Sport Premium funding to support us in achieving our aims.

### **Principles**

The purpose of this funding is to ensure improvement in the quality of sport and P.E. provision for all children. (Department for Education, March 2022).

We will ensure that sport and P.E. provision addresses the needs of all pupils, including those who belong to disadvantaged, vulnerable and gifted groups.

Sports Premium funding is allocated annually following a whole school needs analysis which identifies areas for development, priority classes, groups and individuals.

All our work will be aimed at increasing attainment, participation, improving confidence and skills whilst encouraging a life-long love of sport together with an understanding of the health benefits participation in sports activities brings.

### **Use of Sports Premium Funding**

The school will use the Sports Premium funding and our school budget to action the following:

- to continue to provide opportunities for children to represent school in sport;
- to employ specialist P.E. teachers to work alongside teachers and coaches in lessons to increase their subject knowledge, skills and confidence in the teaching of P.E.;
- to provide CPD opportunities for staff;
- to purchase lunchtime sport activity equipment;
- to provide transport to link with other schools and take part in competitions and festivals;
- to offer our children the opportunity to participate in sport beyond the curriculum;

- to ensure our curriculum offers opportunities for pupils to develop the knowledge and understanding of what makes a healthy lifestyle;
- to forge links with the local community to enrich the P.E. provision within school;
- to buy quality assured teaching resources;
- to subscribe to sports clubs and packages to enhance sports provision and healthy living.

## **Reporting**

It will be the responsibility of the Headteacher, or a delegated member of staff, to produce regular reports for the Governors on:

- progress made towards improvements;
- an outline of the provision with costings;
- an evaluation of the impact of the use of the Sports Premium funding.

There is an annual statement to parents on how the Sport Premium funding has been used to improve the uptake and outcomes for P.E./sports both within and beyond the school day. This task will be carried out within the requirements published by the Department for Education.
